






Goal 2: European Territorial Cooperation

INTERREG: 3 strands and 80 different programmes (EUR 10.2 billion)














Cross-border cooperation



- Around 60 programmes
- Eligible areas: cross-border regions
- Objective: to overcome the borders
- Implementation-related projects












Transnational cooperation



- 15 programmes
- Eligible areas: transnational regions
- Objective: to support territorial integration
- Implementation-related projects









Interregional cooperation



- 1 programme (INTERREG IVC & INTERREG EUROPE)
- Eligible area: all EU regions + Norway & Switzerland
- Objective: to improve policies "Learning by sharing"
- Exchange of experience projects

- ✓ Within other EU initiatives

































Overview priority 1: Innovation & knowledge economy



37 projects involving 395 partners from 26 EU MS & Norway












Rationale








Main features

- <u>Eligible area</u>: EU28 + Norway & Switzerland
- Who is eligible?
 - Public bodies
 - Bodies governed by public law
 - Private non-profit bodies
- Co-financing rates
 - 85% for public or public equivalent
 - 75% for private non profit (RoK 'heritage')

Projects: Main features



Definition

Interregional cooperation projects allowing partner from different countries to work together on a shared regional policy issue within the scope of the selected Investment Priorities

Overall objective

to improve the effectiveness of the policies of the regions involved in the project (in particular their **Investment for Growth and Jobs goal programmes**)











Projects: New features

1/ Implementation in two phases





Policy exchange of experience (1 to 3 years) ending up with production of 1 **Action Plan** / Region



Monitoring of the Action Plan's implementation + possible pilot actions (up to 2 years)

2/ Creation of 'local stakeholder groups'

Platforms: objectives



Overall objective: To ensure policy learning across EU

INTERREG EUROPE: open to all innovation policies


